



**2018 Live Love Young Life 5K and Fun Run
Acknowledgement of Inherent Risk, Assumption of Risk,
Waiver and Release of Liability, and Indemnification Agreement**

1. I acknowledge and understand that there are inherent risks associated with participating in the 2018 Live Love Young Life 5K and Fun Run (hereinafter "the Event") that will be held for the benefit of Young Life Southlake on May 12, 2018, including, but not limited to, those caused by course conditions, facilities, temperature, weather, conditions of the participants, equipment, gear, strollers, vehicular traffic, lack of hydration, actions of other people, including, but not limited to, participants, volunteers, spectators, coaches, event officials, event monitors, and/or producers of the event. I will assume all of the risks associated therewith, whether known or unknown to me at this time. I acknowledge and certify that I am fit to run and/or walk in this event, have sufficiently trained for participation in this event and have not been advised otherwise by a qualified medical person. I hereby consent to medical treatment which may be deemed advisable in the event of injury, accident and/or illness during the Event.

2. In consideration of permitting me to participate in the Event, I release the following entities and/or persons and their directors, officers, employees, volunteers, and agents from responsibility for my accidental physical injury, including death or illness, and loss of, or damage to, personal property while participating in this race: Young Life, and any other event holders, sponsors, directors and volunteers. This release is also intended to include all claims made by my family, estate, heirs, personal representative or assigns. I acknowledge and certify that I will indemnify and hold harmless the entities and/or persons mentioned in this paragraph from any and all liability and/or claims made by other individuals and/or entities as a result of my actions during the Event.

3. I understand that bicycles, skateboards, roller skates or blades, radio headsets, i-pods, MP3 players, and animals are prohibited in the Event, and I agree to abide by this rule.

4. I acknowledge and certify that if I am participating in the Event with my child in a stroller, I assume all risk, and Young Life and the other entities and/or people named in paragraph 2 accept no responsibility or liability for any incidents that may result from my actions as the stroller driver and/or my child's actions as the stroller passenger. I further acknowledge and certify that I am providing my own stroller for use during the Event, and that Young Life will neither be inspecting any of the strollers to determine their condition nor guaranteeing that any of the strollers are fit to be used during the Event.

5. I agree that if I am participating with a stroller, I will start in the designated stroller wave.

6. If I am under age 18, my parent or guardian, by signing below, also consents to my release and he or she agrees that this release shall be binding upon him or her as my parent or guardian as to me and my estate, heirs, personal representatives and assigns. My parent or guardian acknowledges that I am fit to participate in this event, as stated in paragraph 1. My parent or guardian also promises, by signing below, to defend, indemnify and hold Young Life, and the other entities and/or people named in paragraph 2, harmless from any claim asserted by me against Young Life and the other entities and/or people set forth in paragraph 2, including their trustees, employees and agents, if I should repudiate this release after obtaining adulthood. My parent or guardian also agrees, by signing below, that I will abide by the rules stated in paragraphs 3 and 5.

I hereby grant permission to Young Life the right to use, reproduce, and/or distribute photographs, films, videotapes, and sound recordings of me, as well as my child, if applicable, without compensation or approval rights, for use in materials created for purposes of promoting the activities of Young Life.
